

Gymsport Open Gym Rules (under 18)

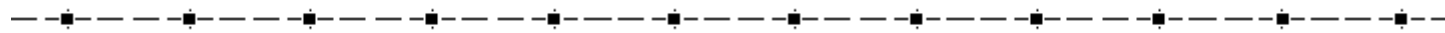
- We require all participants to prepay. Refunds will be given for hours paid for and not used.
- **No** drinks, gum, or food beyond the lobby.
- **No** outdoor shoes, belt buckles, jewelry or jeans beyond the lobby.
- Please keep shirts on.
- Keep language clean. **No profanity.**
- Share equipment and take your turn.
- One person at a time on any piece of equipment.
- Absolutely no spotting other athletes.
- Stay off the carpeted gymnastics floor.
- **No** outside food.
- **No** competition beams.
- **No** bars.
- **No** spring boards.
- **No** diving head first into the foam pits.
- **No** horseplay, chasing others or throwing of equipment.
- **NO preschool equipment, especially Jungle Gym.**

Two strike rule:

1. Warning to stop.
2. Removal from the facility.

If you have been removed twice, you are banned from the gym for one month.

AGREEMENT ("AGREEMENT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY")

I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the activity. I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the Activity.

I hereby release, discharge, and covenant not to sue Gymsport LLC, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered on of the "RELEASES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releases, I will indemnify, save, and hold harmless each of the Releases from any loss, liability, damage, or cost which any may incur as the result of such claim.
