

Preschool Playtime Rules

1. **A waiver must be on file for anyone entering the gym for Preschool Playtime** (this includes parents).
2. **Children must be supervised at all times by an adult.** Please be sure that your child does not interfere with any class that may be in progress. We recommend parents not spend the entire hour on their cell phone. Enjoy this quality time with your child!
3. **Adults are not permitted on the equipment.** The trampoline in the Jungle Gym, the zip line and the preschool bars all have a weight limit of 75 lbs. You are responsible for replacing any equipment you have broken.
4. Preschool Playtime is limited to the Jungle Gym, the smaller Tumble Track trampoline (that exits into the pit), the preschool area in front of the lobby and the equipment on the non-sprung floor. Preschoolers are not permitted on the large trampoline, vaults, or other competition equipment.



Imagine that the gym is divided in half lengthwise (by the poles across the middle of the building). You are welcome to enjoy anything on the lobby half of the gym. The part of the gym with the lights off is off limits.
5. **No shoes, food, drinks, gum, or candy are permitted beyond the lobby. This includes coffee.**
6. One at a time on all equipment (especially the trampoline in the Jungle Gym).
7. Please make sure your child jumps into the pit feet first.
8. When using the zip line or bars, please hold small children by the waist. They may not have the motor control to hold on. Pulling their wrist or arm could result in an unintentional bone fracture.

I have read and agree to abide by the rules of Preschool playtime. I understand that Preschool Playtime is a parent-supervised activity and I may not have a coach present during this time. I agree to do my best to be safe and have fun.
